Requirements for Skills Assessment

Employment

Drug and Alcohol Counsellors provide support and treatment for people with drug and alcohol dependency problems, develop strategies which assist them to set goals and affect and maintain change, and provide community education. May work in a call centre.

Highly relevant tasks include, but are not limited to:

- assessing client needs in relation to treatment for drug and alcohol abuse
- conducting counselling interviews with individuals, couples and family groups
- presenting alternative approaches and discussing potential for attitude and behaviour change

Additional tasks may include:

- maintaining accurate and confidential client records
- referring clients to other practitioners and service providers where appropriate

In Australia, there are currently no legal requirements for licensing or registration for the occupation of Drug and Alcohol Counsellor. Membership of a professional body such as the <u>Psychotherapy and Counselling Federation of Australia</u> may be required by employers.
