## **Requirements for Skills Assessment**

## **Employment**

### Highly relevant tasks include, but are not limited to:

- contributing information, understanding and advice on the learning and behaviour of students, especially those with special needs, and assisting parents and teachers in dealing with these needs
- presenting alternative approaches and discussing potential for attitude and behaviour change

## Additional tasks may include:

- maintaining accurate and confidential client records
- referring clients to other practitioners and service providers where appropriate

In Australia, there are currently no legal requirements for licensing or registration for the occupation of Student Counsellor. Membership of a professional body such as the <u>Psychotherapy and Counselling Federation of Australia</u> may be required by employers.
