Job description

Court Bailiff or Sherriff (AUS) / Court Collections Officer (NZ) implements court orders and serves legal orders and summonses as an officer of the court.

Occupations considered suitable under this ANZSCO code:

Sheriff's Officer (Aus)

Court Bailiff or Sherriff (Aus) / Court Collections Officer (NZ) is a VETASSESS Group D occupation

This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Certificate III or IV.

Applicants can fulfil the assessment criteria for this occupation in one of four ways.

Pathways 1–3

minimum years of post-qualification employment highly relevant to the nominated occupation, completed at an appropriate skill level in the five years before the date of application for a Skills Assessment.

Pathway 4

minimum 4 years of relevant employment required – Three years of relevant employment (can be outside the last 5-year period) in addition to at least one year of highly relevant employment within the last five years before applying.

A positive assessment of both qualification level and employment duration is required for a positive Skills Assessment outcome.

Qualification

This occupation requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Certificate III or IV, and in a field highly relevant to the nominated occupation.

Employment Criteria

Highly relevant tasks include, but not limited to:

- Enforcing the law as an officer of the court by executing court orders such as eviction notices
- Serving legal orders and documents such as summonses and subpoenas
