Job description

Instructs individuals and groups in the theory and application of driving motor vehicles.

Driving Instructor is a Group D occupation

This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Certificate III or IV.

Pathways 1–3

minimum years of post-qualification employment highly relevant to the nominated occupation, completed at an appropriate skill level in the five years before the date of application for a Skills Assessment.

Pathway 4

minimum 4 years of relevant employment required – Three years of relevant employment (can be outside the last 5-year period) in addition to at least one year of highly relevant employment within the last five years before applying.

Qualification

Employment Criteria

Highly relevant tasks include, but are not limited to:

- Instructing students under actual driving conditions, and explaining and demonstrating the operation of brakes, clutch, gear selection, automatic transmission, signals and lights
- > Teaching road traffic regulations
- > Teaching road craft and road safety
- Advising students when they are ready to undergo driving examination
- May advise on and teach advanced driving techniques required for emergency situations
- May illustrate and explain handling and mechanical operation of motor vehicles and driving techniques using blackboard diagrams and audiovisual aids
