Job description

A Massage Therapist performs therapeutic massage and administers body treatments for relaxation, health, fitness and remedial purposes.

Occupations considered suitable under this ANZSCO code:

- Chinese (Tui-Na) Masseur
- Remedial Masseur
- Shiatsu Therapist
- Sports Medicine Masseur
- Thai Masseur

Occupations not considered under this ANZSCO code:

Physiotherapist

Personal Assistant

Fitness Instructor

Beauty Therapist

These occupations are classified elsewhere in ANZSCO or are not at the required skill level.

Massage Therapist is a VETASSESS Group C occupation

This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Diploma or higher. Applicants can fulfil the assessment criteria for this occupation in four different ways.

Description of Pathways

The information below describes the available pathways for a Skills Assessment under **Group C**. Please note that in order to achieve a successful Skills Assessment Outcome, a suitable assessment for both qualifications and employment is required.

Pathway 1

This pathway requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Diploma or higher and in a field highly relevant to the nominated occupation.

Diploma or higher includes AQF Advanced Diploma, Associate Degree, Bachelor Degree, Graduate Diploma, Master Degree or Doctoral Degree.

In addition, it is essential for applicants to meet the following employment criteria:

- at least **one** year of post-qualification employment at an appropriate skill level, undertaken in the last five years,
- working 20 hours or more per week, and
- highly relevant to the nominated occupation.

Pathway 2

This pathway requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Diploma or higher and in a field not highly relevant to the nominated occupation.

Diploma or higher includes AQF Advanced Diploma, Associate Degree, Bachelor Degree, Graduate Diploma, Master Degree or Doctoral Degree.

An additional qualification in a highly relevant field of study at a minimum AQF Certificate IV level is required. Additional qualifications in a highly relevant field of study include those comparable to the AQF Certificate IV.

In addition, it is essential for applicants to meet the following employment criteria:

- at least **one** year of post-qualification employment at an appropriate skill level, undertaken in the last five years,
- working 20 hours or more per week, and
- highly relevant to the nominated occupation.

Pathway 3

This pathway requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Diploma or higher and in a field not highly relevant to the nominated occupation.

Diploma or higher includes AQF Advanced Diploma, Associate Degree, Bachelor Degree, Graduate Diploma, Master Degree or Doctoral Degree.

In addition, it is essential for applicants to meet the following employment criteria:

- at least **two** years of post-qualification employment at an appropriate skill level, undertaken in the last five years,
- working 20 hours or more per week, and
- highly relevant to the nominated occupation.

Pathway 4

This pathway requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Diploma or higher with or without a highly relevant major field of study to the nominated occupation.

Diploma or higher includes AQF Advanced Diploma, Associate Degree, Bachelor Degree, Graduate Diploma, Master Degree or Doctoral Degree.

In addition, it is essential for applicants to meet the following employment criteria:

- at least **four** years of employment at an appropriate skill level that includes at least **one** year of highly relevant employment within the last five years before applying,
- working 20 hours or more per week, and
- highly relevant to the nominated occupation.

Qualification

Highly relevant major fields of study include:

- Massage Therapy
- Remedial Massage
- Traditional Chinese Medicine Remedial Massage
- Shiatsu and Oriental Therapies
- Reflexology and Sports Massage.

This includes qualifications assessed at AQF Advanced Diploma, Associate Degree, Bachelor, Master and Doctoral level.

Employment

Highly relevant tasks include, but are not limited to:

- Massaging the soft tissues of the body, such as muscles, tendons and ligaments, to assist healing
- Utilising a range of massage techniques to enhance sports performance and prevent injury
- Administering treatments to promote relaxation, improve circulation and relieve muscle tension
- Assessing and treating specific soft tissue dysfunction and providing rehabilitation advice
- Employing other techniques, such as acupressure or Shiatsu, and complementary aids, such as infra-red lamps, wet compresses, ice, essential oils and herbal and mineral therapies, to assist recovery
- Assessing a client's physical condition and case history and advising on stretching exercises and relaxation techniques

Employment information

Massage Therapists are often self-employed or working as a contractor for a massage clinic. They also commonly work in the following industries:

- Health and fitness industry (clinics, sports clubs and gyms)
- Sports industry (sporting teams, clubs and individual athletes)
- Recreation and tourism industry (hotels, health resorts and retreats)
- Medical and pharmaceutical industry (medical centres)

Supporting material for assessment

When applying for a Skills Assessment, please ensure you submit sufficient evidence supporting proof of identity, qualification and employment claims. A full list of the documents required can be found on the VETASSESS website under Eligibility Criteria. If you are self-employed or working as a contractor, you are required to provide the following:

- a) Evidence of self-employment such as sole trading or business registration details and / or official statements issued by your (registered) accountant and / or legal team. The statement from your accountant or solicitor must include the accountant's or solicitor's letterhead, your full name, how long you have been continuously self-employed (including official dates in each role), the nature of the business conducted, and the signature and contact details of the accountant or solicitor.
- b) A statutory declaration listing your main duties during self-employment.
- c) Payment evidence showing regular income from self-employment, such as client invoices together with corresponding bank statements and / or official taxation records.
- d) Supplementary evidence, such as contracts with clients or suppliers, client testimonials, evidence of projects completed, or other documents that support your application.
