### **Occupation Description:**

Cabinetmakers fabricate, assemble and install kitchen and bathroom cabinetry, and wardrobes, counters and other fittings from wood and laminates.



#### Their job involves:

- > examining drawings, work orders and sample parts to determine specifications
- selecting and working with materials such as timber, veneers, particle board, synthetic wood and other engineered wood products
- programming and controlling computer-aided design and computer numerical control machines to mark out, cut and shape components
- > working from drawings and specifications to make cabinets and furniture
- > installing cabinetry in bathrooms and kitchens and commercial fitouts
- > making fittings for boats, caravans and other items where fine detail is required
- > assembling parts to form sections of cabinets and furniture and completed articles
- > applying protective coatings to cabinets and furniture
- > fitting hinges, locks, catches, drawers, shelves and other associated hardware.

# Stage 1: Documentary Evidence Assessment

We will review your documentary evidence to ensure it meets the employment and training requirements and indicates that you have the necessary skills, knowledge and experience as a Cabinetmaker.

- A Statement of Results that lists the units of competency you have successfully achieved and those that were not achieved.
