## Job description

Quarantine Officer inspects incoming animals, plants, and animal and plant products to ensure compliance with laws and regulations to prevent the spread of exotic pests and diseases.

#### Quarantine Officer is a VETASSESS Group C occupation


This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Diploma or higher.

A positive assessment of both qualifications and employment is required for a positive Skills Assessment Outcome.

Applicants can fulfill the assessment criteria for this occupation in four different ways.

# Qualification and employment criteria

Applicants must have fulfilled at least one of the following four criteria (1 - 4):



AQF Advanced Diploma AQF Associate Degree **AQF** Bachelor Degree AQF Graduate Diploma AQF Master Degree **AQF** Doctoral Degree

\*\* Additional qualifications in a highly relevant field of study include those comparable to the following levels: AQF Certificate IV AQF Graduate Certificate

minimum years of post-qualification employment highly relevant to the nominated occupation, completed at an appropriate skill level in the five years before the date of application for a Skills Assessment.

#### Pathway 4

minimum 4 years of relevant employment at an appropriate skill level required – Three years of relevant employment (can be outside the last 5-year period) in addition to at least one year of highly relevant employment within the last five years before applying.

\*\*\* Highly relevant paid employment duration (20 hours or more per week)

A positive assessment of both qualification level and employment duration is required for a positive Skills Assessment outcome.



#### Qualification

This occupation requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Diploma or higher qualification. This includes qualifications assessed at AQF Diploma, Advanced Diploma, Associate Degree, Bachelor Degree, Graduate Diploma, Master and Doctoral level.

#### **Employment Tasks**

Additional tasks may include, but not limited to:

- > Examining imported plants and animals, and products, such as timber, seeds and dried fruits, and making quarantine arrangements
- Patrolling and investigating waterways for unlawful fishing activities and the removal of protected marine life
- > May initiate or assist in legal action to enforce regulations
