About this document

Job description

Primary Health Organisation Managers plan, organise, direct, control and coordinate a primary health organisation that provides a broad range of out-of-hospital health services.

Occupations not considered under this ANZSCO code:

- » Medical Administrator
- » Health Practice Manager
- Health and Welfare Services Managers nec (not elsewhere classified)

These occupations are classified elsewhere in ANZSCO.

Primary Health Organisation Manager is a VETASSESS Group A occupation.

This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Bachelor degree or higher, in a field highly relevant to the nominated occupation.

Applicants must also have at least one year of highly relevant, post-qualification employment, at an appropriate skill level completed in the last five years.

A positive assessment of both qualifications and employment is required for a positive Skills Assessment Outcome.



- » Health Administration
- » Health Services Management

** Highly relevant paid employment duration (20 hours or more per week):

one year of post-qualification paid employment (20 hours or more per week) highly relevant to the nominated occupation, at an appropriate skill level in the last five years before the date of application for a Skills Assessment.

Employment

Highly relevant tasks include:

- » Developing, implementing and monitoring procedures, policies and standards for medical, nursing, allied health and administrative staff;
- Coordinating and administering health programs and clinical services:
- » Liaising with other health providers, boards and funding bodies to discuss areas of health service cooperation and coordination;
- » Advising government bodies about measures to improve health services and facilities;
- Providing overall direction and management for the service, facility, organisation or centre;
- » Representing the organisation in negotiations, and at conventions, seminars, public hearings and forums;
- Controlling selection, training and supervision » of staff;
- Monitoring and evaluating resources devoted to » health facilities and centres;

Employment information

Primary care is generally the first point of contact people have with the health system. It relates to the treatment of patients in the community, who have not been admitted to hospital.

A primary health organisation that provides a broad range of out-of-hospital health services is usually a larger facility that provides multidisciplinary health care. For example, it may be a community health service with multiple sites.

Managing a health practice, such as a medical centre/ GP clinic, or dental clinic, cannot be considered for Primary Health Organisation Manager. This role may be considered under another ANZSCO occupation, 512211 Health Practice Manager, which is also assessed by VETASSESS.

If you are nominating this managerial occupation, you must submit an organisational chart. This chart should include the company letterhead, your job position and those of your superiors and subordinates, as well as all positions reporting to your immediate supervisor and to your direct subordinates.
